In the spirit of entrepreneurship, self-nominations are encouraged. 3. You may nominate as many businesses as you wish. 4. All family businesses are eligible with the exception of prior winners. (See list on back of this page.) 5. All nominations must be received by June 1, 2018. 6. Nominated companies will be promptly contacted by us to have them submit a formal application. 	<ol style="list-style-type: none"> 7. Completed applications are due on or before July 5, 2018. 8. Judging will be completed and winning organizations notified by August 10, 2018. 9. Awards will be given in the following categories: (Sized by number of full-time employees) <ol style="list-style-type: none"> a. Large sized business: greater than 50 employees b. Medium sized: 30-50 employees c. Small sized: 10-29 employees d. Very small sized: less than 10 employees e. Old family business: over 50 years f. New family business: under 10 years 10. Applications for companies not selected to receive awards will remain active for three years. (Awards luncheon/presentation to be announced)

Business growth and success Innovative business strategies and practices Contributions to community and industry Longevity (except for new firms)	Family-business linkage Succession preparedness Multi-generation family business involvement (except for new firms)
