Other dates and timeframes to consider:

- After questionnaires are reviewed, letters from the Office of the Dean of Students will be sent to the students who are passed through the committee within 2 business days following the committee meeting.
- Students who the committee denies will receive letters within 5 business days following the committee meeting.
- Students who receive a denial letter will have 5 business days to appeal this decision to the VPSS.
