**How to Transfer Real Property** Owned in a Joint Tenancy

#### **Real Property Owned**

- Joint Tenants (JT) With **Right of Survivorship** 
  - Two or more persons own same property

#### JT can be held between:



- Married couples
- Siblings
- Parents & children
- Person unrelated

#### **Typical Wording Used to Create Joint Tenancy**

• John Jones and Mary Jones as joint tenants with right of survivorship not tenants in common.

  - Each person owns an undivided interest in the same real property

#### **How to Transfer Real Property** Owned in a Life **Estate**



#### **Real Property Owned**

- Life Estate
  - Right to the possession, use & income of property
    - Duration of a person's life

#### **Life Estate Interest**

- Terminated at death of life tenant
  - Transfers to the remainderman without the necessity of probate
