NATE ARAVE - BUREAU OF LAND MANAGEMENT
Nate Arave and Todd Yeager with BLM met with Commissioners to discuss ground that was disturbed on the Wilderness Study Area. Yeager said the BLM understands it was an innocent mistake. The County will need to pay $\$ 2500$ for damages since prior approval was not obtained.

## LIBRARY BOARD

Discussed library board's recommendations for library director and new board member to replace B.G. FitzGerald who has resigned.

## HEALTH CENTER ISSUES

Dan Muniak, PA, met with Commissioners to respond to letter from the Commissioners. Hanz Arnston, Administrator and Sarah Nordlund, DON joined the meeting. Muniak said he does not have time to enter the Electronic Medical Records. Also discussed when nursing home rounds can be made. Muniak left meeting to return to clinic. Discussed donation being made to the Health Center. Nell Phipps put in her resignation effective December 1, 2014. Discussed cross-training employees for different departments.

DAVE AWBERY - ROAD SUPERVISOR
The patrol has been repaired and will be delivered this week.
Bridget Nielson, CMR and Awbery have worked on documentation for grant application. The time frame for the project is fiscal years 2015, 2016 and 2017. Nielson said agreements between the federal and county agencies need to be prepared. Rick Potts's position has been filled by Paul Santavy who will begin work on January 1st. Garfield County \& McCone County Soil Conservation Districts met with CMR officials and it was successful. CMR land acquisitions are almost complete. Discussed issues arising at Hell Creek. Nielson said CMR, BLM and the County all worked well together during fire season. Nielson said BLM is making major changes and everyone needs to be informed. Discussed sage grouse listings. Nielson asked Commissioners to attend CMR meeting on December 4. Awbery said in his absence the road crew was volunteering their time at the ambulance barn.
