BUDGET ISSUES - Health Center

Stanton reviewed the Health Center budgets and reported her findings to those present. The increased number of residents is causing the expenses to rise. Stanton said there should be approximately \$38,000 remaining in the budget. Stanton said last year there was about \$12,000 left in the budget.

JANET GUPTILL -

Guptill reported there was an upcoming meeting between the Corps of Engineers and U.S. Fish & Wildlife Service on Wednesday to discuss the Marina at Hell Creek.

HEALTH CENTER ISSUES

Hanz Arnston, Administrator and Sarah Nordlund, DON met with Commissioners for weekly update. There are currently 21 residents in the nursing home. Discussed Health Center's Frontier status. Arnston said there are health care providers willing to help keep the Health Center in compliance. Nordlund said there has to be someone available every three days. Janet Guptill with the Jordan Tribune joined the meeting. Discussed Stark and Anti-kickback laws. Discussed Health Center's areas of non-compliance and what needs to be done to correct them. Nordlund reported the Red Button was used last week and was a great success.

DAVE AWBERY - ROAD SUPERVISOR

Cosgriff reported the Garfield County Bank would finance a new patrol. Awbery presented information for the bid specifications for the new patrol. Discussed repairs being made to the CAT patrol. Awbery said he would still like to purchase a front-end loader. Discussed which gravel pits are being used. Awbery will be gone next week and Tom Spillum should be contacted in Awbery's absence. The mowing is 2/3rds done.
