PAM WALLING – MACo HEALTHCARE TRUST

Present were Pam Walling with MACo, Janet Sherer, Clerk & Recorder, Charlotte Herbold. Walling said preliminary premium increases were set last week and it appears Garfield County's increase will be .06%. Final rates will be set March 17, 2015. County can offer up to five plans. Discussed wellness screenings. Discussed flex plans. Walling offered to review documentation for County's current flex plan. Discussed insurance for part-time employees.

BRIAN STEFFEN – ACTION FOR EASTERN MONTANA

Steffen, CEO of Action for Eastern Montana met with Commissioners to discuss a Montana Department of Commerce project known as CHDO (certified housing development organization). One of the new projects the Department of Commerce in Helena allows Action for Eastern Montana to grant money for single dwelling homes. This is a non-competitive community development funding. Environmental issues and contractors are taken care of by Action for Eastern Montana. Steffen said he was referred here for a Garfield County resident that needs assistance. County's only involvement would be to handle the funds. Increased insurance costs and additional taxes on the property were also discussed.

Discussed ER protocol and Medial Staff Policy. Arnston will set up meeting with Commissioners, Dr. Drivdahl, Dr. Rauh, Dan Muniak, P.A.C., and Sarah Nordlund, DON. There are currently 20 residents.
