CALL TO ORDER – ROLL CALL

Ryder said the revised by-laws should be approved by June 30, 2015. Contract between Dr. Rauh and Dan Muniak needs to be signed and forwarded to the Medical Board as soon as possible.

Byron went through the completed grant application with Commissioners. Discussed meeting with the coal board.

HEALTH CENTER – Review revised by-laws

Present were J. Randall Rauh, MD, Sarah Nordlund, Dan Muniak, PAC, Hanz Arnston, Administrator, Amari Black, Undersheriff, Cathy Byron, Grant Writer, and Gary Ryder, County Attorney. Robertson asked about the by-laws. Attorney Ryder recommended the Medical Staff review them prior to Commissioner approval. Robertson asked if the supervision agreement between Rauh and Muniak had been signed. Ryder said Black was here due to her concerns over the ER being covered. Rauh & Muniak signed supervision agreement. Rauh and Muniak will review by-laws. Nordlund asked if the by-laws were going to be looked at today. Ryder suggested Rauh & Muniak work on by-laws and then meet with Nordlund, Arnston and Collins. Black asked if an EMT can contact air transport for the ER to make things move faster. Muniak will contact Billings Clinic and St. Vincent's to see if this can be done. Discussed Frontier Status and whether there are any new regulations. Muniak had to leave to attend to patients. Discussed the use of the Red Button. Janet Guptill, with the Jordan Tribune joined the meeting.

EMMA HIGGINS - BIG DRY TRANSIT

Higgins updated Commissioners on transit vehicles and will price new tires for the van. She informed Commissioners she will be on vacation from May 22 - 30. Also discussed policies.

RAY HAGEMAN

Hageman told Commissioners he will be upgrading the 4-wheeler and picking up a trackhoe.

Further discussion on grant application. Collins asked Byron if Stevenson Design will need paid prior to receiving any grant. Byron said we won't know if we get the grants until August. Byron said CDBG will pay for the sidewalks. Byron said we should hear on some of the applications within a month or so. If an application is sent to the Coal Board we would hear in June.

Discussed contract between Garfield County and Muniak. Rauh presented policies for Commissioners review.
