Robertson informed those present that Jane Wille submitted her letter of resignation. Reviewed COA/Big Dry Transit policy. Hains-Hafla indicated Attorney Ryder had reviewed the policy. COA Board will meet July 16th at 12:30 to discuss interim jobs.

Motion by Collins, seconded by Coldwell to approve the COA's policies. Motion approved unanimously.

The COA Board voted to appoint Greg Wolfe as President to fill the vacancy of Jane Wille. The vice-president and secretary shall remain the same.

SHERLIE HAINS-HAFLA - COUNTY HEALTH NURSE

Sherlie Hains-Hafla and Karen O'Dell, Director of Senior Companion Program with Action for Eastern Montana met with Commissioners to discuss grant O'Dell is working on through Homeland Security. O'Dell said one Senior Companion is available for Garfield County. Senior Companions are volunteers who are 55 years of age or older and help seniors stay in their homes. The Senior Companion will be paid mileage and reimbursed for meals. The program

pays for 90% and the County has to pay 10%, approximately \$520.00 per year. If a companion is found they would have to go through training and a background check.

CATHY McKEEVER - LOCAL EMERGENCY PREPAREDNESS

Motion by Coldwell, seconded by Collins to authorize Chairman to sign Communicable Disease Reporting and Sample Transport Plan Protcols for Emergency Preparedness. Motion carried unanimously.
