MARILYN MISCHEL – Action for Eastern Montana – Preliminary Budget

Mischel met with Commissioners to discuss issues relating to the Senior Center. Mischel said a Director of the Council on Aging is not necessary. But the Council on Aging Board still needs to be active. Mischel said the Center needs to be inspected by the sanitarian. Mischel said in the future home chore may be cut but it will be quite awhile before that happens. Discussed preliminary budgets.

Motion by Collins, seconded by Coldwell to authorize Robertson to sign Area I Agency on Aging, Contract # 2016-001-06. Motion carried unanimously.

REVIEW HEALTH PROVIDER'S CONTRACT

Present were Commissioners Robertson, Coldwell and Collins, J. Randall Rauh, County Attorney Ryder, Hanz Arnston, Administrator and Sarah Nordlund, DON. Dan Muniak, P.A.C., was not present.

Robertson asked about the x-ray machine and new telephone system. Nordlund suggested this be discussed after the Grants Advisory Meeting next week.

Attorney Ryder said the meeting could proceed without Dan Muniak being present. Robertson said her concern was that Muniak was not spending enough time with the residents. Attorney Ryder said he had spoken with Muniak. Discussed on-call time. Muniak joined the meeting. Discussed nurse's training, Frontier Status and AVERA. Rauh suggested matters be discussed at the Medical Staff meeting to be held in August.

Reviewed telephone system that Mid-Rivers has available. Arnston and Nordlund left the meeting. Guptill asked if she could have a copy of the Resolution approving the Red Button. Nordlund called the Commissioner's office and stated she will mail a copy of it to Guptill.

DAVE AWBERY – ROAD SUPERVISOR

Discussed whether to repair the trailer or put new axles on it. Awbery said the trailer was so heavy it would be better to buy a different one. Awbery asked where he should get a radiator fixed. Awbery will look for a trailer and will take the radiator to Billings.
