Presentation about the Honors Program - Professor Ilse-Mari Lee

- Honors Program is seeking a change from "Program" to "College," as it will more accurately reflect the rigor, course offerings, success of students, and increased market share.
- According to the National Collegiate of Honors Society, of which MSU is a member, MSU's honors program is already acting in the capacity of an honors college.
- Has checked with U of M counterpart, and the U of M is very supportive of change.
- Currently over 1,100 students in honors program.
- Most universities that have an honors program automatically admit students with a GPA of 3.5 or over. MSU does not. An application process is the process by which a student is admitted to the honors program.
- The honors program has twelve (12), 400 level seminars this 12-13 academic year and all are full.
- Faculty senators will vote to approve (or not) via email ballot.

have been completed; ask faculty attending what FS can do better; hold it during the week after final

- Because this policy will be implemented on all MUS campuses, it will be referred to as an interim policy until all
 campuses are in agreement with the wording.
- An email ballot for acceptance (or not) of this policy will be distributed to senators tomorrow.
