Chair Neumeier called the meeting to order at 4:10 pm, and a quorum was present.

Discussion of How to Strengthen Faculty Senate - Chair Neumeier

- Three main discussion points brought forward by Chair Neumeier are:
 - Empowering senators improve feedback to the senate via actions of senators
 - Examine representation of the senate
 - Evaluate a weekly meeting format what business is conducted in senate each week
- Senator discussion points:
 - What is the role of faculty senate as set out by the constitution, bylaws and faculty handbook? 0
 - Faculty Senate Bylaws and Section 220.00 in the FH will be brought back to senate for discussion next week; links are on the FS website.
 - Presentations from other constituencies often hamper senate meetings.
 - The union and senate should be discussed in the context of collaboration.
 - Senate should conduct 1-2 meetings/month for the sole purpose of senator, alternate and dept head
 - Course material discussions might be scheduled at the latter part of the meeting. Comments about the courses along the approval process should be made available through some medium.
 - Faculty has a union concerned with salaries, benefits, working conditions. Therefore, FS should be charged with addressing, as a group and for all faculty, issues that are primarily academic in nature.
 - Parking, building placement, green space, etc., might be of concern to faculty. Meeting once a month might take place to address those kinds of concerns to discuss, formulate resolutions and send to the Provost and President for action. Chair-elect Mokwa stated that FS might revisit the Advisory Executive Steering Committee, its role in discussing faculty concerns, and deciding whether the issues should come to the senate, or not.
 - Senate should not be used as a clearing house.
 - Identify the role of senate and actualize it. What are the mechanisms to achieve what we represent?
 - Each senator represents a large body of faculty. There should be mutual discussions between administration and faculty. Messages from faculty, as a whole, should be directed to administrators and a feedback loop realized.
 - Reinvigorate senate with regards to its active membership. Recruit senators only after their three-year retention
 - FS might inform or ask administrators how faculty are to be involved in the university's vision.
 - The mechanism for senator nominations is not consistent. Some faculty do not want to become engaged by becoming a member of senate. How do you change that?
 - The perceived marginalization of senate might be because of issues and resolutions often, after leaving the senate, are stalled, to no faulty of senate.
 - A monthly meeting between each senator/dean would improve communications and help to move issues forward. Faculty should remember that department heads are faculty, too, and a team approach with them and deans would be beneficial.
 - Senate meetings should be structured so that the specific issues to be taken to president and provost are clearly articulated, creating a direct pipeline, and that colleagues are aware of that process.
 - Devote one meeting a month, or more, for discussions about campus issues which could then be brought forward to leadership meetings.
