# DGE Staff Reports

- Nursing option
  - a) Paperwork went to the Board of Regents on Monday
  - b) Dean Larry Baker (EHHD--Counseling) and Dean Elizabeth Nichols (Nursing) will meet to discuss mutual use of courses and faculty
- Master of Art in Art History
  - a) Will be considered for final approval in the November Board of Regents meeting
  - b) Missoula supports

- Professional Development Seminar
  - a) First seminar was held October 22, 2008
  - b) 15 students attended the presentation on How to Present Your Research by Dr. Steve Holmgren
- Writing Seminar
  - a) Jen will be meeting with the English department to discuss putting together a graduate writing seminar for international students
- Graduate Coordinators Breakfast
  - a) Carl wants to hold at least one a semester, to discuss any issues that coordinators have
  - b) Office of International Programs presented information on recruiting international students
    - They will show departments the many different ways to recruit international students
    - Libya, Iran, and Korea have recently opened up
    - DGE changed their tuition waiver system to take into account the non-resident status of international students
    - One of MSU's goals is to increase international enrollment
    - The main emphasis was: Do not wait to process an international student a department may be interested in—do it now—the process takes several months (as opposed to the much faster domestic processing)

# Vice Chair -----Carl

- a) Vice Chair replaced Chair when necessary at UGC meetings and then becomes Chair the following year
- b) Chair and Carl discuss proposed Agenda prior to meetings—to be prepared to present issues involved and to decide placement of the Agenda items as to timing
- c) This is a "transition year" to set up members so that 1/3 will transition off the UGC each year
- d) Bonita volunteered to be Vice Chair next year
- e) Members will nominate their choice of the present Vice Chair at the next UGC meeting

## **Graduate Student Advisory Committee**

- a) It is often hard to determine what graduate students want and what they want DGE to do
- b) DGE has tried focus groups and GTA training to try to find out; however, Carl would like to try to see if a more formalized advisory group would be more effective (as found on other campuses); DGE would be a member
- c) The group would help develop ideas and direction for graduates—such as how to interact with other graduates, social activities, professional development, etc.
- d) Many graduate students are unaware of the University Graduate Council
- e) Some students have indicated they would like more information on things like sources of funding for travel and research, tuition waivers, etc.

- f) Yves asked the two UGC student representatives to discuss how the group could be set up to be most workable; they will communicate with Jen in DGE
- g) Discussion followed concerning the need to keep the group small enough to be effective and yet be representative of the students; one student from each of the 20 graduate departments would probably be too large.

#### External Graduate Education Advisory Committee --- Carl

- a) Some graduate schools have external committees with various structures:
  - Primarily community members to help in large fund raising (for scholarships, fellowships, student travel funds, endowed chairs, etc.)
  - A more academic committee (deans, provosts, vice provost for research, etc) to perform a broad spectrum review of all graduate programs (what have you done in the past year and what are your directions for next year?)
  - A combination of both
- b) External Advisory Committee helps look at the whole graduate education picture—is this the best way? Are we going in the right direction? Does this make sense?
- c) Carl wants to bring an external consultant to campus, but before he proceeds further he wants input from UGC
- d) Including local CEOs could bring in new ideas and support—does what MSU is providing match what your industry needs?
- e) The advisory committee could have a standing committee with national members as competition MSU faces is now nation wide
- f) The committee would make sure that students graduating are properly prepared to work in the world outside MSU
- g) The suggestion was made for Carl to continue his research, especially of the larger universities as to what works and what does not work with external committees.

# 570 Independent Study Approvals - Should the 570's continue to come to the DGE for final approval

- a) Donna provided a handout regarding some of the issues involving 570s
- b) The main objective is to find out what is the best approval process for the 570s (departmental, DGE or other options?)
- c) Information provided can be insufficient, causing follow-up with the instructor to provide further details or clarification.
- d) Approximately 70-570s are processed each fall and spring
- e) There is a limit of 4 to 6 credits of 570 on Programs of Study
- f) The DGE review is to make sure that the instructor and student clearly understands what was agreed to, especially as to the grading
- g) DGE can help education department heads, instructors, and admin. associates what the 570 can be used for
- h) Sometimes department heads approve without reviewing thoroughly; if they were the final approval, they would be more careful in reviewing for meeting department standards
- The advisor signature is important as he/she is responsible for the whole program of the student
- j) If approval is decentralized to the department, there may not be over-sight

Motion: Motion was made and seconded to removed the Vice Provost for Graduate Education signature line from the 570 form, and to have the department head/director be the final approval for the 570s. Approved by unanimous vote.

#### <u>Future Meetings</u>

- a) Next meeting is Nov. 6
- b) Nov. 20 is cancelled—due to Board of Regents meeting
- c) Dec. 4—only IF needed for new issues.

## PhD Graduate Reps

- a) Jen reported that in the past, UGC members had agreed to be graduate reps for PhDs who needed one at the last minute
- b) A graduate rep is outside the student's college and must attend the student's oral comp exam and defense
- c) Mainly the graduate rep makes sure there is no discrimination, coaching, or harassing of the student
- d) Members present agreed to be last minute graduate reps.
