Announcements

- Update from Faculty Senate (Wilmer)
 - o Working on faculty handbook revisions
 - Procedural document, does not include "role and scope" revisions
 - Role and scope for departments and colleges will occur after approval of the handbook
 - Promotion and tenure is affected by role and scope document
 - o Approved a 6xx-level course
- Fall 2016 Degree Candidate count (Brown/Cerretti), handout
 - Numbers on handout are estimates. Students will withdraw as thesis/dissertation deadline approaches and passes (Nov 28)
- Coffee Talk Nov 2, 1-2pm, Plant Bioscience, room 108
 - o Tentative agenda provided
 - o Informal setting for updates from The Graduate School staff
 - o Usually well-attended by graduate coordinators and graduate administrative assistants

Old Business

- MS course-only policy change in Computer Science, continued discussion
 - School of Computing revised proposed policy change and Chair Al-Kaisy distributed to Council via email last week
 - One major change:
 - No longer seeking to eliminate comprehensive exam altogether (formerly, option #2 in original proposal)
 - Students with GPA below 3.50 must take the comprehensive exam
 - Maintain that students with GPA of 3.50 or higher will not have to take comprehensive exam; rationale:
 - School of Computing feels this is incentive for students to work harder, do better earlier
 - Students at this level do not need to be further tested
 - Council members expressed support for the revised proposal
 - Chair Al-Kaisy calls for a motion
 - Livingston moves to approve MS courses-only (Plan C) comprehensive exam requirement policy proposal as written (2nd version), LeCain second, unanimous pass. Effective immediately
- IIP proposal update (Hoo) cont. discussion
 - Dean Hoo distributed answers to questions at previous UGC meeting
 - Interim Provost Mokwa gave approval for the intent to plan
 Is not opposed to unorthodox "counting" of students
 - Campus-wide recruitment/admissions committee update (Hoo)
 - Anne Camper (ENGR), Marc Giullian (JJCBE), Tim LeCain (Letters), Doreen Brown (Science)
 - Agreed that a campus-wide committee would be ineffective because of the variability among departments of how recruitment and admissions are implemented
 - History has a dedicated faculty who is given a course reduction
 - Chem/Biochem has a dedicated staff assigned
 - Task Force agreed that composing best practices to distribute to departments would be a better first step
 - Dean Hoo hopes to provide multiple incentives to increase recruitment (tuition waivers, signing bonuses, and so forth)
- Department recruitment/admissions committee update (Hoo)
 - o No update

New Business

- Make reporting of Qualifying/Comprehensive Exams a requirement and permanent part of the student's record (Donna Negaard)
 - o Donna Negaard, Student Services Manager in The Graduate School
 - Defines student record via FERPA; records include:
 - Grades, transcripts, student discipline files, and so forth
 - Info can be recorded in many ways, including email, hand writing, electronic database, and so forth

- The Graduate School does not require an exam but **does** require the **reporting** of the exam **if given**; current policy language does not use the word "required," but intention is implied; should revise language?
- Dean Hoo is asking Council to make the reporting of the exam a policy to maintain a true and accurate record for the student
- Some departments are not reporting all exams (e.g., qualifying exams are given but not reported to The Graduate School)
- Member: not sure all departments know they are supposed to report a "fail" on an exam
 - Graduate School does have policy on number of attempts (2) before dismissal from program and time between first and second attempts
 - Fails should be reported
- Q: Should there be a provisional pass? Or conditional pass, if student did not quite meet standards for all questions?
- Policy & Procedures subcommittee will discuss and draft policy proposal to present to Council at next meeting (Nov 10)
