Announcements

- Ahmed Al-Kaisy, Vice Chair (Hoo)
- Sub committees for spring 2017 (sent prior to Jan 18 meeting)
- Update from Office of International Programs (Prettyman)
 - A Presidential Executive Order (White House) on Jan 27, 2017 created travel restrictions and denied entry for nationals from seven countries (Iran, Iraq, Libya, Somalia, Sudan, Syria, and Yemen)
 - o U.S. Visas are not issued to applicants from any of these countries
 - Those already in possession of visas are being re-examined and denied entry into the U.S. if they were outside the U.S. at time of Executive Order, including students and professors employed in the U.S.
 - o U.S. Visa interview waiver program is suspended for ALL countries
 - Office of International Programs (OIP) is advising any students or faculty from those seven countries to not make any international travel, even those with permanent resident status
 - o OIP is available to advise if guestions arise
 - o MSU has 22 students from affected countries, majority are graduate students
 - OIP advises that if faculty have students they were planning to accept into summer or fall terms, to proceed as usual because situation is changing daily

 Comment: this could be very damaging to recruitment efforts and could create impression that the U.S. is not an inviting or even safe place for international students

• Level II Proposal, PhD Statistics, Statistics Education option (rec'd Oct 2016)

- Guests Dr. Elizabeth Burroughs, Mathematics department head; Dr. Jennifer Green,
 Statistics professor; Katie Sutich, Mathematics program coordinator
- Sent via email with this week's agenda, also available in Course Inventory Management program (CIM)
- o Review of process
- For Statistics students who wish to research teaching and learning in statistics
- Would be unique offering in MUS system and nationally, which will help with advertising and growing the program
- o Q: will program have its own CIP code? Unsure
- Q: does Math have faculty with this specialization available? Yes, two faculty with specific statistics education credentials
 - All Mathematics faculty are supportive of program and willing to serve on graduate student committees
 - Almost all courses are pre-existing; plan is to prepare one special topics (591)
 course
 - MS in Statistics will be required for entry to the PhD program
- Math currently has about 25 MS Statistics students and offer coursework and professional paper options (in other words, no thesis)

- o Program will be distinct from current Statistics PhD program (unlike the Math Education program which is not distinct from the Mathematics PhD program)
- o Comment: Courses not listed in proposal
 - Should be; will double-check CIM for all materials
- Q: what are student qualifications required for program? No specific qualifications other than statistics background; education experience not required
- o Department of Education has given support to program as well
- Hoo: next steps are for UGC to discuss, come up with additional questions for correspondence with department, and eventually vote; then send to Faculty Senate
- Hoo: provost's office requires that resources needed section of proposal is adequately answered;
- Miles (chair of curriculum subcommittee) requests comments from Council to be sent to her this week so that she can put together questions to send to Mathematics department
- UGC meeting during spring break, March 15th, 2017
 - o Not during spring break, many members travelling
 - o Explore option to meet 3/8
- Level II Proposal, History (rec'd Dec 2016)
 - o Will be discussed with guests on Feb 15
