Certified Food Protection Manager Online Resources

Montana requires that school food service managers complete a certification process for safe food handling. Please note, while the Serv Safe certification course has typically been the most common choice for Montana schools, each of the following programs are approved in Montana. Serv Safe is not currently offering proctoring of online exams, while several of the other programs are. *If you need to complete your Certified Food Protection Manager training and testing this summer, you may want to choose another program.*
