RULES:

1. *Confirmation* class will be broke into classes ,hip height for steers, breeding heifer by DOB, Market Lambs by weight and Breeding ewes by DOB, Breeding ewes must be born after December 2018, Market Goats by weight!
2. Showmanship Class will be divided into Beginner (9&under) Junior (ages 10-13) and senior (ages 14-19) AGE AS OF OCT 1ST
Orphan class open to anyone 8 and under – bring your calf, goat or lamb!
3. All Late Entries made day of show must be paid in CASH and include a \$10 late fee per animal.
4. All Exhibitors in the show ring must be clean and neatly attired with appropriate foot wear.
5. The Show management reserves the right to change the show schedule and classes to improve the show.
6. NO Smoking or Alcohol ALLOWED on the DAWSON COUNTY FAIRGROUNDS during this event.
7. Each Exhibitor is responsible for any loss, injury or damage that may result to exhibitor, exhibitor officers, agents, employees, or animals.
8. Registration and check-in starts at 7am. lamb weigh-in and steer hip height at 7. Show will start at 830 with Market Goat showmanship.
9. Wash Rack will be available, some electrical outlets will be available and there is room for fitting chutes.
