The purpose of the Provost Office is to oversee the administrative functions of the University academic departments. This index is the main operational account for the Provost Office.

All academic departments report to the Provost Office.

The reduction of the base budget from FY 2000 to FY 2001 is the result of the transfer of the Institutional Research (IR) function to the President's Office.

The increase from 2003 to 2004 is made up of an increase for the salary of the Assistant Vice Provost for Undergraduate Education and Director of Summer Session that was originally funded on a one-time basis and the salary for the new position of Vice Provost for Undergraduate Education, plus an increase for operational costs of these two positions.

The majority of the increase from FY 04 to FY 05 is a salary change for increased duties and responsibilities for the Assistant Vice Provost for Undergraduate Education and a support position for the Assistant Vice Provost and the Vice Provost for Undergraduate Education.

\$52,000 of the increase from FY 05 to FY 06 is for a permanent operations cost adjustment to the Provost Office for expenses incurred each year in the past paid for from one-time funds from the Provost Reserve.

The Chair and Chair-elect of Faculty Council receive salary release from the Provost's Office to compensate for the time commitment demanded of these positions (50% and 20% release, respectively). This support is institutional in nature, provided with the intent of covering the cost of providing the aforementioned release time appropriate for their involvement in shared governance at the University level. The purpose of these funds is to relieve the faculty member of obligations impacted by serving in these offices.

For FY 2004, the release percentage for the Chair and the Chair-elect went to 60% and 35% respectively. This change and the approval of giving a one course buy-out or, 10% additional compensation, to the Chair of Faculty Affairs and one month of summer support for both the Chair and the Chair-elect account for the increase of the budget over 2003.
