In this position, you will provide construction inspections as well as facility commissioning and startup services.

## Job Responsibilities:

- Provide International Building Code (IBC) required special inspections (Chapter 17) in addition to other inspection services during the construction and commissioning of facilities.
- Interpret contract documents, schematics, manufacturer instructions, codes and standards, and specific client requirements.
- Inspections include trenching-, excavation and backfill inspections, forming
  and reinforcement inspections for reinforced concrete and post-stressed
  concrete, concrete placement inspections, anchor inspections, structural steel
  erection inspections, concrete masonry inspections, piping-, mechanical-,
  electrical-, and HVAC- installation inspections.
- Provide facility commissioning and startup services for industrial production facility and municipal water- and wastewater facilities.
- Facility commissioning and startup includes installation verification, testing, and measurement of mechanical and electrical equipment needed for waterand wastewater treatment plants. Pumping systems, flocculation and sedimentation, aeration, media filtration, digestion, chemical and UV disinfection, backwash systems, electrical and instrumentation systems, and others.
