Operates the chemical feed, membrane racks, and disinfections systems and maintains the mechanical operations of the Water Treatment Plant to ensure the production of safe potable water for City residents; performs directly related work as required.

This is an excellent full-time career opportunity with progressive on the job training for advancement opportunities, longevity pay, and a potential for promotion to lead worker or Foreman status with additional pay, (dependent upon experience, performance, and openings within the department.) The City of Bozeman strives to develop professional Water Treatment Plant Operators and will assist you in obtaining the Class 1 Water Operation Certification if you do not currently possess this item.

MINIMUM REQUIRED QUALIFICATIONS:

- Associate’s Degree in Water Treatment Technology, Microbiology, Biology, Chemistry, or a closely related field; AND
- One year of experience in a direct, conventional, or membrane water treatment plant of at least one million gallons per day capacity; OR
- Bachelor’s Degree in Science, Engineering, or a related field; OR
- Any combination of transferrable experience and training which provides the equivalent scope of knowledge, skills, and abilities necessary to perform the work.

REQUIRED KNOWLEDGE, SKILLS, AND ABILITIES:

- Some knowledge of chemistry and the effects of various chemicals on pH;
- Knowledge of and ability to perform corrective and preventative maintenance on mechanical or electrical equipment;
- Ability to analyze mathematical and physical data in an efficient and precise manner;
- Ability to collect, test, and analyze water samples;
- Substantial knowledge of mathematics, physics, and fluid flow to ensure accurate and efficient measurements and calculations;
