


Over \$8.5 billion in federal government expenditures filtered through Montana's economy to businesses, consumers and state and local governments in 2007, a 6.0% increase from 2006. Nationally, federal expenditures topped \$2.6 trillion, a 4.4% rise from 2006. The table below compares the per capita
