American Community Survey: Three Year Population Estimates

December 9, 2008, the U.S. Census Bureau released three-year estimates for entities with a population of 20,000 or more. With nearly 2 million annual interviews, the ACS survey is smaller than the 18 million housing units that provided long form data for Census 2000. As a result, for smaller populations, the ACS data combines population or housing data to produce reliable multi-year estimates. The data can be found through the <u>U.S. Census Bureau's American FactFinder</u>.

Council of Development Finance Agencies Releases 2008 TIF State-By-State Report

The <u>CDFA 2008 TIF State-By-State Report</u> is a detailed review of the current state statutes and related regulations governing the use of tax increment and similar special district financing tools throughout the country. This information has been collected by CDFA with the help from practitioners in the industry.

Headwaters Economics Creates New Interactive Tool

Research shows there are three distinctly different types of counties in the West, defined by their access to major markets and population centers. 

Jenny's Heroes provides grants of up to \$25,000 each to fund projects that promise long-term community benefits. Funds so far, have been used to provide items and services such as library books, school computers, firefighting gear, nursing home upgrades, free dental services, wheelchairs, and coats for children in domestic violence shelters. The program's focus is primarily on smaller communities where fundraising can be difficult.
