Per Capita Personal Income and Montana Relative to US Average

(BEA) show per capita personal income grew 2.9 percent nationally in 2008 compared to 4.9 percent growth in 2007. Per capita income is calculated as the total personal income of the residents of a state divided by the population of the state. Total personal income includes wages and salaries, transfer payments, dividends, interest, and rental income. Montana's per capita income grew by 3.1 percent in 2008 as compared to 7.0 percent in 2007. For 2008, Montana's per capita personal income was \$34,256 ranking it 38th among the states and improving Montana's ranking from 39th in 2007. Per capita income is used as a broad measure of the extent of improvement in an economy. Rising personal income levels allow individuals to provide for their families, as resourceful leaders in revitalizing buy homes, and improve their standard of living. Montana's per capita personal income for 2008 was \$34,256 compared to \$21,130 in 1998. As the following graph demonstrates, Montana has made significant progress in closing the gap with the U.S. average. In 2008, Montana's per capita income was 86.18 percent of the average for the U.S. compared to 78.6 percent in 1998 and a ten-year low of 76.84 in 2000.


Neighborhood Stabilization Program (NSP) funds The Montana Department of Commerce has published a Request for Proposals (RFP) for projects that would like to utilize NSP funds.

Prospera Business Network Establishes New \$750K Loan Fund Prospera Business Network announced recently that the organization has been awarded funding to establish a new \$750,000 loan fund to assist businesses in Gallatin County and Park County. The funding, which comes through the USDA's Rural Development Intermediary Relending Program and the Montana Board of Investments, is provided to economic development organizations that then make loans to local businesses.

2009 Montana Tourism Infrastructure Investment materials are now available. The 2009 Travel Montana, Tourism Development TIIP Application Deadline is August 3 and they expect to have a \$300,000 Grant Pool. The minimum TIIP Grant is \$20,000. With the required hard match of \$1 for every \$2 the TIIP Grant provides, the smallest project eligible for TIIP grant funding is a \$30,000 project. State Personal Income 2008 info released from U.S. Department of Commerce, Bureau of **Economic Analysis**

U.S. personal income growth slowed to 3.9 percent in 2008 from 6.0 percent in 2007 with all states except Alaska sharing in the slowdown, according to preliminary estimates released recently by the U.S. Bureau of Economic Analysis. The U.S. growth was the slowest since 2003. Inflation, as measured by the national price index for personal consumption expenditures, rose to 3.3 percent in 2008 up from 2.6 percent in 2007. The range of state growth rates was wide. The high end included oil-producing states such as Alaska, Wyoming, Oklahoma, and Texas that benefited from the rise in oil prices, which peaked in the first half of 2008. Annual employment levels in Program (TIIP) Grant Application 2008 in these states exceeded their 2007 levels. At the other end, personal income growth was less than the 3.3 percent national inflation rate in 13 states in 2008. These states include Florida, Arizona, Michigan, and Nevada that had among the largest percentage declines in employment in 2008.


Available grants range from \$1000-\$10,000. The deadline for applying is May 15th.

National Forest Foundation: Mid-Capacity Assistance Program

The National Forest Foundation was established by Congress to support the USDA Forest Service in its management of the nation's forests and grasslands. The Foundation's Mid-Capacity Assistance Program promotes the creation of locally based forest partnerships seeking to resolve natural resource issues through a collaborative, dialogue-based process. Grants of \$35,000 per year for up to two years are provided and require an annual match of \$10,000. Proposals must be received by June 12, 2009.

Baseball Tomorrow Fund

The mission of the Baseball Tomorrow Fund, a joint initiative between Major League Baseball and the Major League Baseball Players Association, is to promote the growth of baseball in the United States and throughout the world by funding programs that encourage youth participation in the game. Grants may be used to finance a new program, expand or improve an existing program, undertake a new collaborative effort, or obtain facilities or equipment necessary for youth baseball or softball programs. Invited grant applications are due January 1, April 1, July 1, and October 1, annually.
