Senator Tester To Host Small **Business Workshop**



US Population Estimates Available

The US Census Bureau recently released population Sept 1. We are excited to announce estimates as of July 1, 2009, for the nation, each state and the District of Columbia by age, sex, race and Hispanic origin. The new estimates are not 2010 Census population counts. Rather, they are based on 2000 Census data and updated by using administrative records to estimate components of population change — namely births, deaths, and through July 15; the full agenda will domestic and international migration. Annual estimates for the 2000 to 2009 period are provided. The images below show data for both the nation and Montana relating to median age rankings.



As reported in New West, the recent Clean Energy-Digest report from Headwaters Economics, looks at the economic results of clean energy and energy biomass. With the recent release of efficiency in the five states we call the Rocky Mountain Energy Producers— Colorado, Montana, New Mexico, Utah, and Wyoming. Clean energy and energy efficiency are among the strongest segments of the overall green economy and often performed better than other areas of the broader economy during these challenging economic times. The graphs below from the report show how green jobs compare to others, and how they are broken down by segment.


Green Jobs by Segment, 2007






A Business Plan for America's Energy Future

Public spending on energy research and development has been in decline for 30 years, and is currently one-quarter of its high point in 1979.




Public Energy RD&D Spending as a Share of GDP, 2007

2009 Montana Incorporated City/Town/Place Population Estimates

The Montana Census and Economic Information Center (CEIC) recently posted the US Census Bureau's new population estimates for cities and towns in Montana. All 129 incorporated places in Montana now have updated population figures as of July 1, 2009. These new populations are not a result of the recent Census 2010 survey, but a product of the Census Estimates program. The first city and town population data resulting from Census 2010 will be released by April 2011. The map below shows the distribution of incorporated and unincorporated places.
