Come join our team and be a part of managing your national forest. The Dillon District recreation and trails crews manage 3 rental cabins, 5 campgrounds and 400 miles of trails.

- **Forestry Technicians** will accomplish a variety of tasks supporting the recreation and trails programs:
  - Primary duties will include participating in general maintenance of campgrounds, trails, trailheads, vaults, monitoring use and compliance.
  - Additional duties may include:
    - Check outfitters for compliance with management plans and operating instructions
    - Campground safety inspections
    - Trail maintenance, bridge construction, chainsaw use
    - Crystal Park safety inspections and maintenance
    - Assist with end of year reporting
    - Collect and process fees



**These positions require physical exertion, in rough terrain, in a full range of weather conditions.** Work week schedules vary depending on the position. Some positions and projects require camping out for extended periods. \*Forest Service Housing is not available at this time.



## HOW TO APPLY:

**CONTACT** the hiring manager identified on the previous page to get more information about the job, work location and USAJOBS announcement number and application due dates.

**Step 1** – Create a USAJOBS account (if you do not already have one) at [www.usajobs.gov](http://www.usajobs.gov). It is recommended that as part of your profile you set up automatic email notification to be informed when the status of your application changes. If you choose not to set up this automatic notification, then you will have to log into your USAJOBS account to check on the status of your application.

**Step 2** - Create a Resume with USAJOBS or upload a Resume into your USAJOBS account. You may want to customize your resume to ensure it documents duties and accomplishments you have gained that are directly related to this position in order to verify that qualifications are met. In addition, your resume must support your responses to the online questionnaire (you may preview the online questionnaire by clicking on the link at the end of the How You Will Be Evaluated section of the job announcement).

**Step 3** - Search for the job announcement number or simply click on the provided hyperlink. Please read the entire announcement and all the instructions before you begin. Click "Apply Online" and follow the prompts to complete the Occupational Questionnaire and attach any additional documents that may be required (such as transcripts). Make sure you select your potential duty station.

You can update your application or documents anytime while the announcement is open. Simply log into your USAJOBS account and click on "Application Status." Click on the position title, and then select "Update Application" to continue.

\*Hiring managers will request applicant lists from USAJOBS and selections will continue until positions are filled.

\*Remember to identify the town where the ranger district resides as a potential duty station, to ensure your application is made available to the hiring manager you contacted.
