Minutes reviewed. Motion by Sandy, Second by Cody. Passed.

**Treasurers Report** \$26,436.70 in checking. Ended up with Net Income of \$8,496.18 for last 4-H year. Special notation to please properly request expenses through the office. Checks cannot be written without proper procedures. Several members received Awards Checks and there wasn't an expense report or meeting minutes detailing such available. Bookkeeper will have Livestock budget worksheets for the officers to work on prior to January meeting.

## **OLD BUSINESS**

Rules for the following were reviewed and voted on from the October meeting.

Rule Changes: Noted in the proposed 2022-2023 Rule Book

Show Committee Rule Addition: If there are any changes to be made to the schedule of the show while at the show the show committee will be called together to make changes to the show. This is for emergent situations. Motion by Michelle, Second by Sandy. Carried.

Update to the interview judging that all species including breeding projects need to have their projects up to date as of the county show interview judging to be allowed to show at the county show. Motion by Jill, secondy by Cody. Carried.

Marketing Your Project paragraph removed, it is clarified in the new paragraph. Motion by Sandy, second by Aimee. Carried.

Adding clarification that rabbits and poultry need to be inspected by the division chair prior to placing them in cages at the show. Motioned by Jill, second by Cody. Carried.

Breeding Project: Adding Dairy to breeding project. Re-writing breeding project description to designate options within the breeding project and to clearly define expectations. Motioned by Sandy, second by Jill. Carried.

Round Robin rule clarification and adding the format of the competition to the rule book. Adding a 2 minutes per animal to show and then switching animals for 2 minutes before switching species. Motioned by Michelle, second by Liz. Carried.

Clarification on load out procedures, that 4-H members need to make arrangements with another 4-H member and inform the division chair via documented means by the close of the show. \$50 fee will be withheld from their sale check. Motioned by Sandy, second by Michelle. Carried.

Meat Pens: Simplifying the rule book to eliminate double wording by removing from Animal Limits and adding a section on pages 11/12 under Individual Species Rules, MeatPens to clarify the meat pen descriptions and separate them from the show rabbits and poultry that are shown and taken home. Motioned by Jill, second by Aimee. Carried.

Awards: Grand and reserve champions will choose from three award choices at each level. Buckle or equivalent prize at the show. Prizes will be offered at the show. Motioned by Sandy, second by Cody. Carried.

Other changes that were made for clearer understanding/editing from October meeting.

- Change title page from "Show and Sale" to "Rule Book."
- Addition of new Extension office emails to the Rule Book.
- Add title for "Marketing Visit Required" to point out the need to market their project. Add that it needs to be included in My 4-H year under Promotional Presentations.
- Change the title of "Notebook" to "Record Book"
- Move grievance procedure to page one under general information. Grievance committee should consist of the show committee.
- Rabbit meat pens definition updated with clarification on breeds that are allowed to be sold. Poultry meat pen definition updated for clarification of expectations.
