He graduated with a B.S.A from the University of West Virginia.

Charles Potter is a Charter Member of the Alpha Chapter of Epsilon Sigma Phi which organized in 1927. He and M. L. Wilson are the only two living Charter members.

He set the stage for 4HH Club work in the state of Montana and put it on a very sound basis. Most of the basic programs that he introduced are still in effect. He was an excellant administrator. Not only the assistants who worked directly under him but also all of the Extension Agents during his administration and all the 4-H members and leaders found him a stimulating and loyal Leader.

As evidence of his administrative ability, Mr. William A. Lloyd, at that time Supervision for the Western States, tried repeatedly to get him into the Washington office. After a number of years refusing, the offer was made so attractive that he could not afford to turn it down.

Before leaving us he wrote up a most comprehensive history of Club work from its inception until his date of leaving. This is largely incorporated in the Montana Extension History which is being written.

His is really an Extension family. He married Barbara Heidner who was the Home Demonstration Agent in Blaine County, Montana when he met her. They have two girls and a boy. All are married now and there a great many grand children.

This seems a very meagre report for all that Charles Potter has done for the Extension Service and Epsilon Sigma Phi. I wish I could quote from the

from the many letters received with members votes for Charles nomination.

I am enclosing the copy of the letter covering the ballot which was sent out to absent members at the request of our Executive Committe. I do not remember whether I enclosed one with my last letter to you. I think we had an excellant response in 77 voting out of our total membership, especially when some of the votes came a long way. The last vote today was from Uganda, Africa.

I trust that this nomination for the Certificate of Recognition is not arriving too late to be counted.
