## **Forest Stewardship Workshop Frenchtown May 4-5 & 12, 2023 (Thursday-Friday & Friday)**

Dear Stewardship Participant,

This letter will provide the information needed to locate the meeting place and hopefully answer any remaining questions. You will begin your learning experience before even stepping foot into the classroom. In this packet, you will find some very important tasks to complete before you come to class. If you have difficulty with them, reference the handouts and instructions again or do your best and bring what you have completed to class. Please bring all pre-class material with you to the workshop. The first step is to look through the material and the pre-class assignment. To receive complete benefit from the course, **it is extremely important to complete all homework in advance, which requires a few hours of effort.**

Check-in is at 7:30-8:00 on the first day. We cover a large amount of information at the workshop and try to stay on time at all sessions, so please be on time or a bit early. Be prepared to spend 16-24 hours between the second and last day of the workshop on your property completing a stewardship inventory and gathering vital information about your property.

The workshop will be held at the Frenchtown Rural Fire District Station, 16875 Marion Street, Frenchtown, MT. See the map below for the location.

From I-90 take Exit 89 toward Frenchtown, turn left north onto Demer Street, take a left onto Beckwith Street, turn right onto Ducharme Street, and turn right onto Marion Street. The fire hall is on the left.

Through the course of the workshop, you will complete a management plan for your property. You will be provided a paper copy to write your plan. I encourage you to bring your laptop if you prefer to type your plan. The file for the plan is available on our website: <https://www.montana.edu/extension/forestry/forms-to-download/index.html>. I will also have it available on a flash drive for downloading at the workshop. You are encouraged to bring pencils and writing pad.

We provide coffee and tea. Please bring a lunch and any snacks and drinks you may need during the day. You will have about an hour for lunch. There are few eating establishments in the near vicinity. However, you are encouraged to bring your lunch, as this is a good time to visit with other participants and the advisors. The second day, the outdoor training day, please bring a lunch, hat, sunscreen, rain gear, boots, and water.
