The Montana State University Extension Pesticide Education Program (PEP) is an educational program promoting the proper use of pesticides to protect public health and the environment. This program is for individuals and their employees who wish to apply Restricted Use Pesticides (RUPs) to land they own, rent or lease for the purpose of growing an agricultural commodity. At the conclusion of the training, new applicators will be able to receive the Montana private applicator pesticide license.

Currently certified applicators may attend the training to obtain their six pesticide education credits for the cycle.
