
#### Deterra Medication Disposal Pouch Instructions


Tear open pouch and place unused medications inside



Fill pouch halfway with warm water and <u>wait</u> **30 seconds** with bag open for air to release. Some foaming may occur.



Seal pouch tightly, gently shake and dispose of in normal trash.

Prescription opioids include: Codeine Diphenoxylate (Lomotil) Fentanyl Hydrocodone (Vicodin) Methadone Morphine (Kadian, Avinza) Oxycodone (OxyContin, Percocet) Oxymorphone (Opana)

Illegal opioids include: Heroin Illegal Fentanyl

Nationally, 614,000 teens aged 12-17 have admitted using the prescription stimulant Adderall for nonmedical reasons at some point.

Prescription stimulants include: Adderall Ritalin Dexedrine Diet aids like Preludin, Fastin, Meridia

# **PRESCRIPTION OPIOID AND STIMULANT MEDICATION**

### **Proper Usage**

- Do not share your medications.
- Use a medication log/journal.
- Take medications as directed and keep them in their original containers.
- Before you start taking an opioid medication, ASK YOUR DOCTOR:
- Am I at risk for addiction? Will something else work? How long will I be taking this? Are you prescribing the lowest possible dose? What is the plan to taper me off?

## **Proper Disposal**

- Deterra Medication Disposal Pouches are an at-home medication disposal method. When mixed with warm water, the pharmaceutical compounds are rendered inactive and safe for your household trash. Do not exceed the maximum capacity for pills, patches and liquid form medications indicated on the back of the disposal pouch. See instructions on the back of this brochure.
- Don't have a Deterra Medication Disposal Pouch? Take your medications out of their original containers and mix them with an undesirable substance such as cat litter or used coffee grounds. Put the mixture into a disposable container with a lid or use a sealable bag and place in the trash.
- Remove or black out with a permanent marker your name and prescription number to protect your identity before disposing of the empty prescription container.
- Community Drug Take-Back-Programs allow the public to bring unused medications to a specified location. These events are hosted every April and October. For specific dates and to find a site near you visit https://takebackday.dea.gov/

### **Proper Storage**

- ALWAYS keep your medications locked up, out of sight and out of reach of children or pets.
- ALWAYS keep medications in their original container.

In 2019, over one in ten MT high school students reported taking a prescription drug without a doctor's prescription.

Needles Thermometers Hydrogen Peroxide Inhalers Lotions Liquids Aerosol Cans
