

**RESOLUTION NO. 638**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TROY, MONTANA ESTABLISHING THE PROCEDURE TO TRANSFER FUNDS WITHIN ACCOUNTS IN A FUND**

WHEREAS, the Troy City Council is responsible for the fiscal health of the City; and

WHEREAS, the City Council and the Mayor, after careful consideration, allocate city funds into separate accounts within a fund; and

WHEREAS, the City Council desires that its budgetary considerations be followed when expenditures are made; and

WHEREAS, the City Council believes it is wiser to obtain pre-approval of expenditures that exceed the budgeted amount than to disapprove a claim after the expenditure has been made;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Troy, Montana that the City Clerk not transfer monies between accounts within a fund or draft checks that exceeds a budget in an account without the prior approval of the City Council.

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TROY, MONTANA ESTABLISHING THE SCHEDULE AND CONSTRUCTION OF THE WATER FEATURE.**

The completion date shall be no later than November 1, 2011.
