1985 GOVERNMENT STUDY PROGRAM FOR THE TOWN OF MELSTONE, MONTANA

The Government Study Committee for the town of Melstone, Montana was authorized by the primary election of 1984 with a vote of 26 for and 25 against the study commission. Since no one had filed for the offices before the general election time, the county clerk and recorded failed to prepare a ballot for the election and no one was elected. Legally, when less than the required three are elected, the mayor with the consent of the council can appoint to fill the vacancies. This should be done at the first council meeting after the election. The clerk called around among the voters, asking for people to serve. Many refusals were received, but finally four persons did agree to serve. These four were Paul Zentner, Patti Lang, Bonnie Opie, and Robert Rostad. The Mayor appointed Bonnie Opie, Patti Lang and Paul Zentner the council approved. Notices were mailed out and the information that they were to organize within ten days was included. The oath of office was enclosed in each letter. The position of ex-officio member a member of the administrative staff was also necessary. This is a non-voting position. Clara Mae Spek was appointed to this spot. Oath of offices were all returned signed.

The organization meeting was set for December 10, 1984 at 7:30 PM in the clerk's office, Attorney Pratt was asked to attend.

MINUTES OF THE ORGANIZATION MEETING. December 10, 1984

Present were Patti Lang, Bonnie Opie, Paul Zentner, Attorney John Pratt, and Clara Mae Spek. Attorney Pratt gave a handout on the laws ruling this commission. They were read and discussed. Copies of the 1974 commissions final report was given to every member present. Patti Lang was chosen President and Bonnie Opie was named Secretary. The seminar in Bozeman was discussed, no one wanted to go. Due to the shortness of finances it was decided to ask Roundup's delegation to pick up as much material for us as possible. Maybe, we can meet with the Roundup delegation later and get a report from them. First regular meeting to be set in early January, at the convenience of the committee. Signed Clara Mae Spek, Clerk.

Some study has shown that according to section 7-3-178 a recommendation of no change may be adopted, after study and following certain proceedures. This would finalise committee action within 30 days after such decision

was made public.

February 21, 1985— The resignation of Bonnie Opie was received. She had moved to Helena. At the regular meeting of the council, March 12, 1985, the letter of resignation of Bonnie Opie, was read and accepted. The Mayor appointed Robert Rostad to fill the spot. Robert was officially notified on April 1, 1985 and signed his oath of office on April 4, 1985.

Thursday, May 2, 1985 Patti Lang and Clara Mae Spek met at Clara Mae's home and did some studing of the manual and drew up a tentative form to be used as our tentative plan, all discusions have led to a total plan of NO change.

May 13, 1985, 7:30 PM Meeting at City Hall. Present were President Patti Lang, Robert Rostad, and Ex-officio Clara Mae Spek, acting as Secretary, Open discussion on what we wanted to do; what could be done; and what had to be done, based on the study manual. Our tentative plan as drawn up by Patti and Clara Mae was shown to Robert and openly discussed. It was decided to have our first public meeting at the Fire Hall, Thursday, June 6, at 7:30 PM. Advertising to be run in the May 22 Issue, and posters posted in the various business spots in town. Patti will conduct the meeting and coffee and cookies will be served. Meeting adjourned. Signed Clara Mae Spek, Clerk.

Many different points of reference were noted. Again the point of no change in our final report was discussed. After talking to John Pratt after the May 13, meeting the date for the first Public Hearing was changed to June 20, so he could attend. Notices were in the June12 and 19 Roundup Record and notices posted in public places in Melstone.

The first Public Meeting of the Melstone Government Study Commission of 1985 was held in the Melstone Fire Hall at 7:30 PM on June 20, 1985. Only 7 persons showed, all of which were either town officials or members of the study commission. The town attorney was there also. From this, the assumption was drawn that very little interest in change was present. Meeting was called to order by Chairperson Patti Lang and turned over to Attorney Pratt. A plan of NO change was presented and openly discussed. Such plans seemed agreeable to all present. The presented work sheet was adopted with no suggested changes by those present. This will be accepted as the tentative report of the committee. Discussion of time and date of the next required public meeting was held. It was agreed by all present that the next, or second public meeting be held at 7:30 PM on July 18, 1985 at the Fire Hall. Meeting adjourned and coffee and cookies were served.

July 18, 1985 second Public Government Study Meeting held for final adoption of report. Final Draft of NO change, for 1985. Meeting called to Order by Clara Mae Spek at 7:30PM in the Melstone Fire Hall, 8 persons present. Flossie Sike being the only interested citizen, the others were either members of the City Council or the Study Commission. The plan, as published in the paper, of NO change was again presented. No new discussion. Motion to accept the NO change report was made by Paul Zentner and seconded by Robert Rostad, it passed with no objections. It was agreed that the final reports to the necessary departments be drawn and signed, and that the final meetingbe held, to be sure that all, angles were cared for. At which time the committee be relieved of their duties, within the 60 days, as proposed by law. It is hoped that some educating be done before the next cycle, so that people know what they are voting for. Such final meeting will be held on October 1, 1985.
