Summary of Recommendations

The Sunburst Local Government Study Commission, having thoroughly studied our present form of town government and the alternate forms of government available to towns under state law and anticipating the future needs of the town, recommend the following:

That the incorporated town of Sunburst keep its present form of government.

That the incorporated town of Sunburst make some changes with respect to present laws and ordinances. (See Finding of the Study Commission)

Findings of the Study Commission

After a study of the government of the Town of Sunburst, it is the decision of the study commission to keep the present form of government that the city voted on in the year 1976.

The study commission feels that improvement is needed in these areas:

- 1. A better working agreement with Toole County on the police protection that the city currently employs.
- 2. City budget/expenditures be posted every month. (Suggest Post Office be considered as place)
- 3. Enforcement of ordinances. Major concerns are clean-up and dogs. Citizens should make <u>written</u> complaints so that the town can act to enforce ordinances. Written tickets should be forwarded to the Justice of the Peace for collection.
- 4. Have at least one city clean-up day a year. A reasonable fee could be paid before pick-up.
- 5. City employees need to be accountable for their performance. Suggest a written work-log to be reviewed by the council with follow-up...are things getting done? Are city employees using city time and resources for outside work? (Double-dipping, ie. Sweet Grass Water System)
- 6. In order for our city government to be effective, decisions made by the council need to be actively supported by each member of the council. Also each council member should assume chairmanship of one of the following areas:
 - a. water and sewer
 - b. garbage and clean-up
 - c. streets
 - d. gas

Minutes for the Sunburst Study Commission January 18, 2005
