Private applicators in Lincoln, Flathead, Sanders, Lake, Mineral, Missoula, and Ravalli counties should be sure they have attained 6 private applicator credits prior to the January 1st, 2014 deadline to avoid losing their pesticide license. Applicators can assess their credit information at https://app.mt.gov/pest/index by selecting 'view education credits' and entering their private applicator license number.
