#### Sanders County 4-H 2020 Fruit Sales February 9-19

Fruit Sales are the largest fundraiser each year for Sanders County 4-H. It has been very successful thanks to all the work of the 4-H members and families and the supporters of the 4-H program. By now members should have received information by email and an order form from your club organizational leader for the sales of oranges & Grapefruit.

## If you haven't received an order form yet contact your organizational leader.

Members who sell 8 cases or more of fruit will receive a t-shirt for their work and members selling 20 cases or more will receive a gift card from Ripples Ice Cream Parlor of Plains in addition to the t-shirt. It is VERY important members give the money received from the sales to the club leader ASAP! This will allow the club to earn the maximum percentage allowed from the club sales. Your club will receive 5% of the fruit you sell if earnings are submitted to the Extension Office no later than <u>March 18</u>. Earnings submitted March 19-April 1 will earn your club 3% of what your club sold. All sale earnings submitted after April 1st will go to the Sanders County 4-H council. Remember, you must turn all the money from your sales in to your club leader so your club leader may submit your total club earning to the Extension Office.

## <u>Submit a T-Shirt Design</u>

Members who are interested in submitting a design to put on the t-shirts are encouraged to do so. Submit your design to the Extension office by <u>February 24</u> and see if your design is chosen. This is open to any Sanders County 4-H member. If you have any ideas we encourage you to give it a try. We look forward to seeing 4-H creativity!

#### Important Rec Lab Date

Interested Sanders County 4-H members must submit a \$50 fee and a completed medical release form to Sanders County Extension Office. Early Bird registration March 25th, \$75; Regular registration April 18th \$100. (Sanders County 4-H Council contributes the balance).

Youth participants must be 13+ as of October 1, 2019.

#### Lodging

Participants will be housed at a school facility and should bring: sleeping bag, air mattress or sleeping pad, towel and other personal items. Youth must be accompanied by a registered adult chaperone. A chaperone and travel arrangements for Sanders County 4-H participants will be arranged.

## What's Our Responsibility When Involved in 4-H?

Unable to be at the sale with your market animal? Unable to attend the required number of club meetings? Rules are meant to be fair to everyone, as well as provide structure to the 4-H program. However, we realize that unusual or special circumstances do arise from time to time that need to be considered. The Sanders County 4-H Council has made available a Request for Rule Exemption form. This form is to be completed by any 4-H member who requests a special consideration regarding any county rule that is in place. The request will be considered by the Sanders County 4-H Executive Committee. Hopefully, thinking through the questions will allow members to look at the large picture and how the request will affect not only themselves but those around them. ## Montana Livestock Per Capita Reporting

All Montana Livestock owners must report the number of each type of livestock they own on February 1 each year. According to Montana state law (15-24-921, MCA), livestock owners need to report "cattle, sheep, swine, poultry, honey bees, goats, horses, mules, asses, llamas, alpacas, domestic bison, ostriches, rheas, emus, and domestic ungulates." Once reporting is complete, livestock owners pay a per capita fee which funds Department of Livestock programs for monitoring animal health, tracking livestock important. movement and preventing livestock theft, and managing predators. 4-H members are considered livestock owners, so do need to report. In the event that a 4-Her loses livestock to wildlife predation, they will only receive reimbursement from the Montana Livestock Loss Board if they previously paid their livestock per capita fees.

There are Horse, Sheep, Swine and Plant ID Learning Lab kits available for checkout from the Extension office. Additionally Beef, Poultry and Dairy kits are available from the State 4-H Office. If you would like to check out any of these kits for a project meeting contact the Extension office.

# **12th Annual U.S. Targhee Sheep Association Starter Flock**

#### THREE FREE REGISTERED TARGHEE SHEEP TO BE AWARDED TO DESERVING YOUTH

The U.S. Targhee Sheep Association (USTSA) will agin, for the 12th straight year, be offering a free registered Targhee Starter flock to a deserving youth at the 2020 USTSA National Show and Sale, held July 16-18, 2020 in Redfield, South Dakota. In previous years members of the USTSA have awarded 18 starter flocks, totaling 60 head of sheep and have also donated almost \$13,000 towards buyers credits for the award winners to purchase additional sheep at USTSA national sales. The winner must be present to receive the flock and will be awarded one (1) ewe lamb, one (1) yearling ewe, and one (1) brood ewe donated by members of the USTSA. Each animal will be a USTSA registered animal and at least QR in Scrapie Codon 171 genotype. The winner will also receive a \$150 credit for use toward purchase of additional animals at the 2020 national sale.

Sanders County 4-H Council MEETING MINUTES FEBRUARY 4, 2020 CLARK FORK PROFESSIONAL BUILDING

Pledges were recited.

Minutes of December's Meeting: approved as written.

Agenda Review: No changes.

**Treasurer's Report**: None. There have been a number of fraud cases in the area recently. Recognizing that council officers are volunteers and time can become limited, the council must be diligent about staying on top of the budgeting and expenditure details. A Treasurer's report will be provided at the April meeting. **Correspondence**: None

#### Old Business

Livestock Committee Report: The committee has a balance of \$6,929. Logistics of the round robins are being finalized, Fair improvements are being discussed, and judges are being sought. The Horse committee has updated their policies and procedures. Swine quality assurance training is on February 10.

Ambassador's report: No meetings have been held yet this year. A regular meeting schedule is being constructed. Record book committee: The state record book app was recently launched and will allow for real-time record-keeping. Info will be sent to members soon.

#### <u>New Business</u>

**Fair Projects**: Plans for shelving at the pavilion and restroom repairs are forthcoming. Juli will talk to the Fair Manager about a new lock for the storage room door. The Fair Board will be asked if converting the bathrooms under the grandstands to vendor showers is in the works for this year; a grant may help support that effort.

**Budget Proposal 2019-2020**: A proposed budget was not available. There is some confusion regarding which Managed Agency Account funds are available for use and which are intended endowments (and just the earnings are intended for use). Juli will ask a representative from the 4H Foundation to review these details at the April Council meeting for clarification.

**Fundraising**: Fruit sales are scheduled for Feb 9-19. Kim will build the order submittal app and distribute to leaders. T-shirt designs for top sellers are due Feb 24. Council approved the selection of Sanders county 4-H as beneficiary of the Avista Golf Scramble on August 15. Juli and Ashley will be primary contacts and council members will be committee members. The dinner, auction, and donation card ideas were tabled until further notice. Growing Clover Crowdfunding is a new program that Juli came across, information was distributed. Grants will be applied for as needed; Juli is maintaining a list of sources.

**Council Officers**: In light of potentially changing officers, Joanne mentioned there are ways to vote people in that can serve as secondary signers on checks or act as Co-Treasurer to satisfy the need to have signers on the bank account in close proximity to each other. This may allow for inclusion of members on the Council and to act as Officers even if they are located near each other to ease financial transactions. These options will be discussed more when officer positions change.

Scholarships: Four graduating seniors qualify for scholarships. A report of available funds will be provided at the April meeting.

**Communication Days**: Whitepine Happy Workers will host lunch in Thompson Falls on March 7. Hot Springs Wranglers will host lunch in Hot Springs on March 8.

Hometown Welcome Program: The Clark Fork Valley Press asked the Council to consider advertising in their flier that is mailed to new residents in Mineral and Sanders counties. It does not seem to be a good fit for Sanders County 4-H.

<u>Announcements</u>: Registrations for Communication Days are due by February 5. The county 4H website is undergoing a major upgrade and is much easier to use. Members are encouraged to check it out for forms or information they may need. Club payments for manuals are due to the Extension Office.
