


#### **4/H/FFA Livestock Projects**

4-H/FFA members learn the principles of livestock nutrition and how to apply them; to train and safely handle the animal, and to accept the consequences of one's work and use the results to formulate future goals. The animals you will find at the Sanders County 4-H/FFA Stock Sale are the culmination of a year's worth of work and a product of members striving to reach their goals. Livestock are raised under the standards of quality assurance. Your participation and support of 4-H/FFA through this sale is greatly appreciated.

#### **Buyer Participation**

If possible, you will want to attend the sale in person. Sale Committee members and ring volunteers will be on hand to assist with your purchase. If you or your business cannot attend, but still wish to participate in the sale, you can do so by proxy. Proxy buyer forms are available by contacting the Sanders County Extension Office.





### Ways to Buy

- Beef, Sheep, goat, or hog purchases are processed and graded following the sale. Your animal may then be cut and wrapped at an establishment of your choice. A nominal charge will be assessed for the killing, cutting and wrapping. All fees will be assessed from the cut and wrap location. Friends and neighbors may share a purchase, if a whole animal is more than you can use. Sheep, goats, swine and beef are taken to Superior Meats in Superior for initial processing. Buyers have their choice of Western Montana processing plants for final cutting & wrapping.
- Businesses can make a tax deductible purchase for employee functions or goodwill gifts. Organizations may purchase meat for a club barbecue or fund-raising activity. Purchased meat may also be donated to a favorite charity.
- 3 **RESALE** Buyers may consign their purchase for resale. The buyer then pays only the difference between the actual bid and market support price. Resale information will be provided at the start of the sale.

**Note:** Animals will be sold by the live weight indicated on the sale sheet available at the sales arena Sunday morning. Maximum weight buyers will pay for swine is 300#/animal, and for beef 1500#/animal.

Buyers please remember animals must be processed in order to obtain carcass results.

Meat Rabbits, meat chickens and meat turkey's will be eligible to be sold through the market sale.
