Quality Assurance

Shooting Sports Dress Code

An addendum will be added to the fair book, Shooting sports dress code will be as follows: Arm guards are required, and long hair must be tied back behind the ears.

Shirts:

4-H collared shirts or t-shirts are acceptable.

Snap, button or pullover collared shirt or t-shirts or polos without graphics.

For safety reasons, tank tops, and shirts showing the midriff area, are not allowable while participating in 4-H shooting sport activities.

Pants:

Jeans, without holes or slacks.

Shoes/Footwear:

Casual shoes, tennis shoes, or boots. For safety reasons, shoes must cover the entire foot and must be closed toe.

Air rifle: Normal low-cut, street-type or athletic shoes, including toe shoes, must be worn in all positions. Shoes may not extend above the midpoint of the ankle and must have a flexible sole.

Shooting jackets and special shooting pants are not permitted. Special shooting sweaters, shirts, or jackets with additional or special pads are not permitted.

LEADERS COUNCIL MINUTES

Stillwater County 4-H Leaders' Council Minutes March 16, 2022 @ 6pm Stillwater County Extension Office - South Annex

*Due to extreme temperatures and weather, the February 23rd, 2022 Council meeting was canceled and items on the agenda were moved to the March agenda.

Meeting was called to order by President Melissa Kramer @ 6:04pm. The pledges were recited, no correspondence to share. Those in attendance were Stephanie Wright (Johnny's Buckaroos), Jeanna Fry (Park City Wranglers), Sarah Leland (Park City Wranglers), Tammi Kirch (Beartooth Ramblers), Brian Young (Stillwater Ranch Hands), Haley Barker (Extension Agent), Lee Schmelzer (Extension Agent), Mike Baker (Park City Wranglers), Raya Jackson (Extension Office), Kathy Hollar (Beartooth Ramblers), Suzi Smith (Johnny's Buckaroos), Meredith Feddes (Johnny's Buckaroos), Katrina Feddes (Johnny's Buckaroos), Shannon Moore (Johnny's Buckaroos), and Melissa Kramer (Johnny's Buckaroos).

<u>Reports:</u>

Teen Leaders - Mike Baker shared that there were about 60 4-Hers that attended the Teen Leader Pizza and Game Day. They are now collecting donations and getting ready for the Easter Meals that they put together for community members in need. They are looking for donations of pies, and will probably need about 15 of them. Posters are being put up around town for people to sign up to receive meals. The Teen Leaders have decided to go to Silverwood in August. 4-Hers must be signed up as a Teen Leader before/by June 1st to go on the trip.

Travel Program - Tammi Kirch advised they have purchased their tickets for Washington D.C.! The group will be gone from July 23rd to July 30th. There will be four 4-Hers participating in this trip.

Homemakers - Haley Barker advised that there is interest from Lisa Weber (Park City Wranglers) to run the concession stand at Fair. She has experience running the concessions at Ravalli County Fair. She would offer a condensed menu and operate Wed, Thurs, Fri. Lisa would organize, cook and manage the concessions, clubs would still provide volunteers for service and sales. Profits from the sales would come back to the 4-H program. Do we offer to pay Lisa for her time, knowledge and skills? It sounds like it was the arrangement she had with Ravalli County. Haley will look for numbers, days and info before we vote on it. Do we still invite Food Trucks? We may still be able to get Lila & Rick to do the Buyer's Lunch. Also, clubs are still welcome to pick a morning and sell breakfast items during Fair week if they would like.

Fairgrounds Report - Lee, Brian & Stephanie attended the latest FCIP on March 10th. Because of the rise in cost of materials and what specific funding is currently available, the county will move forward with the first phase of development being a 12,000sq ft Pavilion and the 20,000sq ft open-sided Livestock Building on the new fairgrounds building site. It was stated that the Stillwater County Fair will not be displaced due to construction of other phases of county improvements and 4-H will not lose access to current facilities and sites until the new ones are built. Concerns for animal health and safety with Montana's weather and temperatures due to an open-sided livestock building were brought up. Some new info is being collected to see what it would take to enclose the building, insulate the roof and install a cooling system. The pavilion would still contain a concession area similar to the current one, the bathrooms, and some indoor storage. For size comparison, the current pavilion is 10,000sq ft with 7,000sq ft available open space. The east end of the Livestock Building will be completed in such a way that it can easily be extended in the future or another building butted up against it. The parking lots will be gravel to start with. There will be a 6ft chain link fence up along the canal and 5 strand smooth wire around the rest of the perimeter. The next FCIP meeting will be March 24th, 8:30am at the West Annex for anyone interested in attending.

Suzi motioned for Council to pay for the lunch, Brian 2nd the motion, motion passed.

4-Her of the Year, Volunteer of the Year and License Plates - be thinking about nominations for each of these honors, can take it back to your clubs for suggestions. Turn in nominations by May.

MT Gives - May 2-6th this year. Haley requested approval for the \$150 registration fee. Brian made a motion to approve the registration fee. Mike 2nd the motion. Motion passed.

Sno-Cone Sales at Fair - Park City Wranglers is requesting permission to sell sno-cones during Fair week. Meredith motioned for the Park City Wranglers to be allowed to sell sno-cones at Fair, Tammi 2nd the motion, motion passed.

Heifer Futurity Update - 11 signed up, 12 heifers are enrolled, Merit and Futurity classes are moved to the beginning of the classes so the 4-Hers will have time to fit their animals before Showmanship and the rest of the classes. Records for Futurity Heifers are due by the time of the Fair Interviews.

Shooting Sports - Stephanie noted that the revised dress code for shooting sports did not make it into the Fair Book. An amendment page will be sent out with the revised dress code to be included with the Fair Book.

Campers must be enrolled in the 2021-22 4-H year as a member (not a Cloverbud) in Yellowstone County. Applications are accepted on a first-come, first-served basis-space is limited. 4-H Members from Carbon and Stillwater counties also attend. A letter regarding camp specific (what to pack/bring, bus pick-up/drop off times, etc.) will be mailed to each camper a week prior to camp.

Camp Fee: \$165 per camper without a scholarship request letter OR \$100 with a scholarship request letter. Make checks payable to: Stillwater County 4-H Council. <u>Payment must be included with application!</u> Please note: The Stillwater Council pays an additional \$160 per camper to cover all camp costs.

4-H Camper Code of Conduct

- 1. Have fun and be safe! Participate in all activities! Be on time!
- 2. Wear your name tag (except when sleeping, swimming, or showering)!
- 3. Drink water regularly (just not from the streams)!
- 4. Stay on the premises!
- 5. If you feel sick or get hurt, tell a camp nurse or an adult!
- 6. Girls only in girls' cabins. Boys only in boys' cabins!
- 7. Wear and bring appropriate clothing for all kinds of weather. Letter tells you what to bring. One-piece swimsuit or tshirt over 2-piece swimsuit; hat off in dining room; coats for snow; raingear; shoes on when walking outside.
- 8. Keep cabin areas and campgrounds clean at all times. Cabins will be inspected daily. Clean cabins will be first in line for lunch and dinner. Dirty cabins will clean the public restrooms.
- 9. Each cabin will have certain responsibilities assigned to them at some time during camp. **EVERYONE** in that cabin needs to be there to help. Schedules are posted in the cabins and in the dining hall.
- 10. Telephones are to be used ONLY in case of emergency.
- 11. The ringing of the bell means to come right away or move to your next activity. If the bell rings when you are in your cabin day or night—go **IMMEDIATELY** to the bell.
- 12. NO: Fireworks! Foul language! Alcohol! Illegal drugs! Tobacco of any kind! Items that could cause harm to other campers!
- 13. Have a counselor, CIT, or adult with you to go into a cabin.
- 14. During quiet time/sleeping time, remember to be quiet for sleeping and for being good cabin neighbors!
- 15. Follow the direction of camp leaders. Respect the property and rights of the camp, other campers, counselors, CITs, and adults at all times.
- 16. If riding the bus to/from camp, I agree to check in when I get on the bus and check out when I depart the bus with the county agent.
