Entry Guidelines for submitting Abstracts/Posters:

(1) Follow the instructions for submitting an abstract and return by August 27, 2019 to jlf@montana.edu.

Abstracts should include the following types of information.

- *State the main objective and rationale of your research, project or educational program.
- *Outline the methods you used to accomplish your objectives.
- *List your project's results or products.
- *Raw conclusions about the implications of your research, project or educational program.

(2) A separate abstract must be submitted for all selected papers and selected posters proposed for presentation at the Western Region NACAA AM/PIC.

(3) Abstracts should be clear and concise, as they may be used in meeting publication materials. All abstracts will be published. The text should not exceed 350 words. Abstracts will be prejudged for acceptability.

(4) Posters may reflect the work of one member or two or more members working together. If multiple members participate, they must be listed on the abstract.

(5) Posters will be on continuous display during the Western Region NACAA AM/PIC. Posters will be peer-reviewed and judged by the Western Region NACAA Selected Papers/Posters Review Committee and other pre-selected Western Region NACAA members.

(6) You should bring all needed exhibit materials with you to the Western Region NACAA AM/PIC. Size of the display should be no larger than 44" X 44". We will follow NACAA guidelines for posters. NACAA will supply display boards for posters. Complete instructions will be sent to selected poster presenters.

(7) The Western Region NACAA Selected Papers/Posters Review Committee will peer review and have authority to accept or reject proposed selected papers/posters upon evaluation of the abstract. The decision of the committee is final.

(8) Work reported in the session must have been completed within the most recent three years.

(9) At least one presenter for each selected paper/poster must be registered for the NACAA AM/PIC on or before **September 12, 2019**.
