<u>Announcements</u>

• New policy proposals have been removed from the agenda due to the upcoming break; they will be brought back in spring 2015.

Old Business

- o Curriculum Committee Level II Proposal PhD in Psychology (Committee member Miles)
 - Department clarified (via email, but not stated in the proposal) that the current Master's degree is not eliminated – will be MS en route to PhD.
 - Concern raised that the proposal is still unclear about the Master's degree. Is the Master's degree a terminal degree? Or are students only allowed to apply for the PhD and receive the Master's en route?
 - Some editing concerns for clarity is recommended for advancement of the proposal to the next level.
 - UGC (chair of UGC curriculum committee) will send a letter to the department and Faculty Senate that includes suggestions for improvement and the vote decision by UGC.
 - Motion to approve, Council member Christensen moved, council member LeCain second
 - Unanimous approval Council member Babbitt abstained.

<u>New Business</u>

- o <u>Guidelines for Review of Curriculum Changes (Dean Hoo)</u>
 - Associate Provost Larsen shared with Dean Hoo that Faculty Senate already approved guidelines for review of graduate curriculum changes without informing UGC.

- Course deletions can effect multiple departments.
- Departments that require courses from other programs need to be informed (e.g., Education requiring Statistics, but Statistics does not have sufficient resources)
- o PhD Enhancement Award (Policy & Procedures Committee)
 - Time sensitive Notice needs to be sent before end of Fall 2014 semester
 - Evaluation criteria/rubric needs to be approved
 - Last year, some proposals failed to address PhD enhancement aspect of the proposal and only addressed undergraduate teaching
 - Should emphasize quality teaching experience for students
 - Students who are awarded are tracked for continuation of this award
 - Multiple year awards are ideal as long as the department qualifies
- Doctoral 12 Credit Requirement policy proposal (Policy & Procedures Committee)
 - Tabled Committee members Codd and Babbitt to add language and send to the Policy & Procedures Committee and the Dean of the Graduate School.
- <u>By-Laws Modification (Governance Committee)</u>
 - Modest in changes
 - Proposal: The Dean of Graduate School and Faculty Senate Member representative should not have voting rights (i.e., ex-officio, non-voting members); the senate member acts in an advisory role, the Dean looks to UGC for recommendations/suggestions
 - Alternate college members have voting rights when designated members are absent
 - A Faculty senate member who serves on a UGC sub-committee is intended to serve in an alternate capacity
 - Should there be proxy votes?
 - Concern: If a council member misses a meeting/discussion, they may not be informed enough to vote.
- Role of Faculty Senate Members (Governance Committee)
 - The current faculty senate members stated that he would like to vote.
 - Discussion:
 - Should they vote?
 - What is the role of the Faculty Senate member? S/he is not assigned to UGC by a college dean. They attend as part of UGC by-laws.
 - What does the faculty senate member bring to UGC meetings that other council members do not?
 - Chair Dyer called for a vote to change the by-laws to allow Faculty Senate members to vote on issues that do not go on to the Faculty Senate.
 - Council member LeCain motioned, Council member Babbitt second
 - o Unanimous approval
 - Revised UGC by-laws will be reviewed by UGC in spring 2015
- Graduate Student representative as a part of UGC
 - Discussion:

- Should there still be a student member? Inconsistent attendance in the past
- Should the student member be allowed to vote?
- How is a student chosen? Deans recommend a student for this role, rotates among departments.

- It is a burdensome to ask a student to attend these bimonthly meetings and to stand-in and represent all Graduate students.
- Should the student member be removed from the by-laws?
- Student input is useful on some issues
 - UGC members are to ask their graduate students and report back to UGC in spring 2015?
- Possible role of a Graduate student is as a consultant on topics agreed to by UGC
