# February 3, 2021 minutes

  - o Motion passes: 8 in favor, o opposed, 1 abstention

- o Polling faculty about priorities for 2022-2023 strategic plan goals

# Co-convening Policy Discussion

- Overview of Subcommittee's draft: focus on graduate experience first and undergraduate education and enrichment second. Potentially eliminate the need for policy limiting the number of co-convened courses.
  - Focus on graduate learning outcomes
  - Undergrads could have less assignments, but the atmosphere would be graduate level
- Call for feedback:
  - Achieved goal of graduate level courses, instead of 4xx level course with a few extra assignments for graduate students
  - Item #1: only 4xx/5xx level courses may be co-convened
    - 3xx: global studies courses, learning another language could be a core part of graduate level curriculum
    - Should we review the 3xx level prohibited policy instead of allowing as coconvened?
      - There are existing exceptions for language courses: (ex: Art). Other programs could be added as an exception, if applicable.
      - o Clarification: exception would just be for language courses
      - Continue to allow rare exceptions rather than change policy
    - Question regarding tuition waivers for 3xx level provisional courses: can these be eligible for tuition waivers?
      - o Dean Ogilvie will confirm and send email to Council with more information
  - Item #5: enrollment of at least 50% graduate students
    - No matter how rigorous you make the course, if 90% enrolled are undergraduates, it's not truly a graduate course
    - Does the course get cancelled if enrollment doesn't meet the 50% mark?
      - o Review logistical challenges of monitoring enrollment in each course
    - Suggested wording: co-convened course enrollment is recommended to be at least 50% graduate enrollment
    - Once a year could work with OPA to conduct analysis. Work with departments that don't meet the threshold on shifting to more of a graduate experience.
  - Item #6: 3.25GPA requirement for undergraduates
    - 3.25 or instructor permission, could be waived
    - Discussion on logistical challenges
      - o Dean Ogilvie will ask Registrar's Office for feedback
  - Item #4 all 4xx level co-convened courses reviewed by UGC
    - Is reviewing 4xx level courses outside the scope of UGC?
    - If supposed to be a graduate level course, could be appropriate for graduate council to review it
  - Is long-term goal to eliminate co-convened courses and move to full graduate courses? Or is this a good pedagogical model to use co-convened courses?
    - Open discussion
- Dean Ogilvie will ask registrar about item #6, subcommittee will revise based on UGC's feedback, revisit at next meeting
- Certificates in Crop Breeding & Biotechnology and Plant Disease:

- o Open for comments on revised proposal:
  - Pg 4: addressed concern about students repeating 4xx/5xx level courses
  - Why is Crop Breeding in PSPP, Plant disease in Agriculture?
    - Not sure why can ask for clarification, but does not need to impact vote
  - Are there any concerns with no financial aid eligibility?
    - Program will need to go through separate process to pursue financial aid eligibility; encourage all graduate certificates to apply
    - Does not have to be approved for financial aid before UGC approves
  - o Dunlop motions to approve the two certificates, second by Giullian
    - Motion passes: 8 in favor, o opposed
- MENG-Civil Engineering & MENG-Environmental Engineering, Level II Proposal: proposer working on revisions

#### **New Business**

#### • Associate Graduate Faculty

- Overview: currently well-established senior research scientists and professionals that do not hold tenure track status cannot chair a graduate student committee. Policy proposed to allow these individuals to chair a committee. Eligibility would be reviewed by the department. Provides a path for departments to approve qualified members of our community to chair committees.
- O these associate faculty need to have the highest degree in their field, or not chair a committee above their highest level of degree? Should a master's chair be required to have completed a thesis before advising a thesis (versus coursework)?
- o Could put department in a potentially political situation making this decision
- Research faculty or affiliate faculty may not be aware of all the requirements of exams/defense/etc. Open to this with flexibility for departments to figure out how this works in their departments.
- Discussion on how this is different than the idea of "graduate faculty status" presented in the past
  - Associate graduate faculty would expand the tent instead of making it smaller. In contrast, graduate faculty status would have created a subset of tenure track faculty.
- Workload/union aspect for NTTs: if NTT agrees to be a chair of a committee, could become a financial impact for the department to cover
- o Suggest revising "minimally qualified faculty" wording
- What happens if NTT chair doesn't pass their affiliate faculty renewal? What happens to the student's committee?
  - Maybe appointments one year past expected graduation date
  - If expires, finish existing committees but not take on any new students
- Is this something that research faculty want?
  - Feedback from directors that staff would be interested
  - Nursing would be interested—have many NTT faculty
- NTT can't be paid with grant money
- o Suggest Faculty Affairs subset of faculty senate reviews the proposal
- Dean Ogilvie will revise the proposal with UGC's feedback, check with NTT representative, then send update to Watson and Mannheimer to take to Faculty Affairs subcommittee, return to UGC
