Announcements

- Update from the Dean
 - Grad Fair October 26th-28th
 - Junior/Senior night October 26th
 - First Generation Day November 9th
 - o Graduate School Compassion Week October 24th-28th
 - University's goal to increase quality and number of international enrollment, eventually reaching an additional 1,000 graduate students in several years

- Focus is likely graduate students in professional master's programs (e.g. arch, public admin, environmental science, computer science, cybersecurity, MENG degrees).
- Faculty will have opportunity to shape the development of this plan.
 - When these companies come to visit MSU, an opportunity to get faculty and graduate student feedback
 - May be helpful to bring to faculty senate when plans are further defined
- Discussion on housing
 - Plan to request BOR permission for additional university housing, possibly apartments, on campus
 - University Student Housing is discussing how to prioritize f new graduate students
 - The international recruiting company may sign a master's lease off campus to reserve housing for international students
- Discussion on need for faculty and staff in departments and central units like grad school and OIPto keep up with increased enrollment

• Faculty Senate update (Thomson):

- Informational items: employee ADA and appeal policy, research misconduct policy
- o Allison Harmon provided VPR office overview
- Bill McKenny from Dean of Students presented code of conduct updates
 Once code of conduct policy is updated, UGC can discuss this policy
- Megan Lasso and Provost to talk about faculty salary at the upcoming meeting
- Governor's budget going to the legislature with 4% raise

Old Business

- DNMW-DNP Doctor of Nursing Practice Nurse Midwife new program proposal
 - Revisions were added to CiM: letter of support, IHS does hire midwives and they are eligible for loan repayment, midwives can setup their own independent practice, employment opportunities are abundant
 - Warnat motions to approve, Reinert seconds
 - Proposal passes: 7 in favor, 0 opposed, 0 abstained

New Business

- Feedback on draft limits to GTA appointments
 - \circ $\,$ 2 main motivations: best interest of the student, opportunities for new students to get funding
 - Proposing 10 semester limit on the number of semesters doctoral students can receive GTA and tuition waiver. Receive notice ~1 year in advance. The department head could request an extension. Want to encourage people to finish within the limit, but still provide flexibility for life circumstances.
 - What if appointment is half GTA half GRA?
 - Current proposal is if more than 1/3 of the time, that would count as a GTA semester

- Humanities PhD programs don't have external funding: would need slightly longer
- Currently ~5% of graduate students are over the proposed limit, with some students between 20 and 26 semesters
- o Balance between supporting experienced GTAs and giving new students an opportunity
- Review and send feedback to Dean Ogilvie
- Continuous enrollment policy draft (policy subcommittee)
 - Audit fee language: "may" charge a fee in exceptional cases
 - Adding considerations for returning student regarding funding
 - Added: Previously arranged funding is not guaranteed upon re-enrollment and will need to be re-evaluated.
 - Potential vote at next meeting
- Bylaws state that the Vice Chair should be elected
 - Review at next meeting
- Subcommittee Updates
